1st RACE Voided 2 claims - submitted by the same stable for a single horse

The claim of #7 "Hasten" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

2nd RACE Voided 2 claims - Insufficient funds

The claim of #1 "Box Office" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3rd RACE CLEAR

4th RACE #8 "Action Player" (Gabriel Saez) was injured in the paddock and was a late scratch on the advice of the KHRGC veterinarian

5th RACE Super HI-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.


6th RACE #11 "Mytilya" (Flavien Prat) was pulled up in the stretch and required the assistance of the KHRGC veterinarians and the horse ambulance. The filly was placed on the See State Vet list.

#12 "Sweet Kaufy" (Lanfranco Dettori) finished fourth and suffered a post-race heatstroke. The filly, who required treatment from the KHRGC veterinarians, was placed on the See State Vet list.

8th RACE Super HI-5, Superfecta, Trifecta and Show wagering were not offered when the field was reduced to four prior to the opening of wagering
