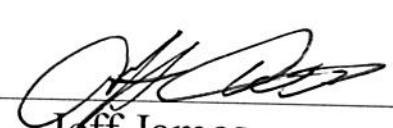

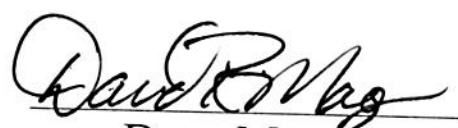

- Race 2 - #1 Rally Your Crew was scratched during the Post Parade by the State Vet – Lamé – 14 Days – Must Qualify.
- Race 2 - #7 Ain't It A Beach was placed on the Judges List – Poor Performance.
- Race 2 - #8 Crispy Crunch was scratched during the Post Parade by the State Vet – Lamé – 14 Days – Must Qualify.
- Race 2 - #2 JD's King James was placed on the State Vets List – Post Race Lamé – 14 Days – Must Qualify.
- Race 6 - #7 Dynamic Desire was placed on the Judges List – Did Not Meet Qualifying Time.
- Race 7 – After the $\frac{3}{4}$ mile marker #5 Youngblood took a bad step and fell causing an accident which caused the driver of #5 and #7 to be unseated. Due to the massive interference and confusion, and the accident caused the outrider to ride into the field of horses to catch #7 Outbound Train to avoid further problems and harm to anyone, the Board of Judges called a NO CONTEST and all wagering was refunded. Both Drivers were checked by the medical team, and Marvin Luna was transported to a local clinic for further evaluations. Archie Buford was cleared to drive the remainder of the day. Both horses were evaluated by the State Vet and attending vets, no major injuries and they were being tended to.
