1st RACE The claim of #8 "Espere" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

2nd RACE #5 "Sugar Boo" (Julien Leparoux) BOLTED and was eased. The horse was placed on the Stewards' List.

After reviewing the race replay and interviewing the riders of second place #1 "Bellamore" (Martin Garcia) and third place #6 "a Mo Reay" (Flavien Prat) the stewards determined that #1 drifted out repeatedly through the stretch and impeded the progress of #6. For the interference, #1 was disqualified from second and placed third, behind #6.
