TEST: 1<sup>st</sup> 2 & 7, 2<sup>nd</sup> 3 & 4, 3<sup>rd</sup> 2 & 5 (C 1), 4<sup>th</sup> 4 & 6, 5<sup>th</sup> 5 & 7-clm voided (C 3), 6<sup>th</sup> 3 & 7, 7<sup>th</sup> 6 & 9, 8<sup>th</sup> 4 & 5.

1<sup>st</sup> RACE Superfecta and Trifecta wagering were not offered when the field was reduced to four prior to the opening of wagering.

Voided claim - wrong racetrack listed

#1 "Traffic Pattern" (Jon Court) was a late scratch from the post parade on the advice of the KHRC veterinarian. The late scratch reduced the field to three, necessitating the cancellation of Exacta wagering. Management also opted to cancel Show wagering. The mutuels department made the proper refunds.

2<sup>nd</sup> RACE #4 "Secretly Wicked" (Javier Padron-Barcenas) popped the starting gate door open prior to the break, but was held in place. The door was closed and the start was without incident.

3<sup>rd</sup> RACE CLEAR

4<sup>th</sup> RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

5<sup>th</sup> RACE #6 "Western Pharoah" (Gabriel Saez) bolted, was eased, and was placed on the Stewards list.

The claim of #7 "Stone Slinger" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

6<sup>th</sup> RACE #6 "Pirate Rick" (Martin Garcia) was a late scratch from the post parade on the advice of the KHRC veterinarian. The late scratch reduced the field to five, necessitating the cancellation of the Superfecta. Management also opted to cancel Show wagering. The mutuels department made the proper refunds.
