1st RACE Superfecta, Trifecta, and Show wagering were not offered when the field was reduced to four prior to the opening of wagering.

2nd RACE Superfecta wagering was not offered when the field was reduced to five betting interests prior to the opening of wagering.

3rd RACE Due to the races being taken off the turf, this race was contested on the main track at the distance of one mile, as specified in the conditions of the race.

A Stewards' Inquiry was posted involving second place #2 "Silver Blur" (Reylu Gutierrez) and third place #5 "Buehler's Day Off" (Geovanni Franco) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #2 came out into the path of #5 causing him to steady and lose momentum. For the interference #2 was disqualified and placed third behind #5. Official order of finish: 4-5-2-1

4th RACE CLEAR

5th RACE Superfecta, Trifecta, and Show wagering were not offered when the field was reduced to four prior to the opening of wagering.

6th RACE CLEAR

7th RACE Superfecta, Trifecta, Exacta, Place and Show wagering were not offered when the field was reduced to three prior to the opening of wagering.

8th RACE Due to the races being taken off the turf, this race was contested on the main track at the distance of one mile, as specified in the conditions of the race.
