#4 "Moochie Girl" arrived past the Lasix administration deadline and was permitted to race without the medication. The change was posted and announced prior to the opening of wagering.

6<sup>th</sup> RACE There was a 40 minute delay prior to the running of race 6 due to a storm with heavy rain and lightning in the area and the necessary track maintenance. Management made the decision to take the scheduled turf races (6<sup>th</sup>, 8<sup>th</sup> and 9<sup>th</sup>) off the turf. Those changes were posted and announced prior to the running of race 6. During the delay the horses remained in the paddock. The remaining races were eventually run over the sloppy track without incident.
