

- **Race 2** → #3 Western Era was scratched out of the post parade by the recommendation of the State Veterinarian and was placed on the vets lists for 14 days and must qualify.
- **Race 6** → #5 Facing The Giants was pulled up after the $\frac{3}{4}$ mile marker and Did Not Finish. The Board of Judges asked the State Vet to inspect any issues. State Veterinarian determined Atrial Defibulation and will be placed on the Vets List for 14 Days and must qualify.
- **Race 6** → #8 Blaz N Chip was placed on the Vets List – Atrial Defibulation – 14 Days and must qualify
- **Race 11** → There was a delay prior to the 11th race due to heavy rain and lightning. After roughly 55 minutes the track was confirmed to be in good shape and the weather had passed and the races were allowed to continue without any further delays.
