TEST: 1st 6 & 7, 2nd 3 & 4, 3rd 2 & 4, 4th 2-voided & 3, 5th 7 & 8, 6th 4 & 7, 7th 3 & 6, 8th 3 & 7, 9th 1 & 10.

1st RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

2nd RACE CLEAR

3rd RACE Super Hi-5 wagering was mistakenly listed in the official program as a option, but wagers were not accepted as the race was carded with six horses.

In addition, Superfecta wagering was not offered when the field was reduced to five horses prior to the opening of wagering.

4th RACE A Stewards Inquiry was posted when #7 "Southern Sunset" (Joseph C. Bealmear) unseated his rider leaving the 3/8 pole. After reviewing the race replay, the stewards determined that #7 BOLTED entering the turn and unseated the rider. There was no action taken and the race was posted official. The horse was placed on the Stewards list.

The claim of #2 "Iceatude" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

5th RACE An objection was lodged by the rider of fourth place #8 "Biggiebiggiebiggie" (Rafael Bejarano) alleging interference by the rider of the unofficial winner, #7 "Argos" (Axel Concepcion) in the stretch. After reviewing the the race replay and interviewing the riders, the stewards determined that #7 angled out slightly in front of #8 in the stretch, but that there was insufficient evidence of interference to warrant a disqualification. There was no change in the order of finish and the race was posted official.


6th RACE CLEAR


7th RACE CLEAR

8th RACE #5 "Scythia" (Edgar Morales) was injured in the paddock and was a late scratch on the advice of the KHRGC veterinarian. The scratch reduced the field to six, necessitating the cancellation of the Super Hi-5. The mutuels department made the proper refunds.

9th RACE A Stewards Inquiry was posted involving the start of #7 "Send Cash" (Brian J. Hernandez, Jr.) when the rider was unseated soon after the start. After reviewing the race replay, the stewards determined that the horse stumbled after an awkward start and unseated the rider. There was no action taken and the race was posted official.
