TEST: 1<sup>st</sup> 7 & 8 (C 3 & 6), 2<sup>nd</sup> 2 (C 4-voided), 3<sup>rd</sup> 3 & 8 (C 1-voided & 5), 4<sup>th</sup> 4 & 8, 5<sup>th</sup> 3 & 4, 6<sup>th</sup> 2 & 5, 7<sup>th</sup> 1 & 2, 8<sup>th</sup> 1 & 6, 9<sup>th</sup> 1 & 9.

1<sup>st</sup> RACE CLEAR

2<sup>nd</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.  
 #6 "Hard Rye Guy" (Rafael Bejarano) was a late scratch from the post parade on the advice of the KHRC veterinarian. The late scratch reduced the field to five and necessitated the cancellation of the Superfecta. The mutuels department made the proper refunds. A claim that had been submitted for the horse was voided.  
 The claim of #4 "Smokin Hot" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.  
 3<sup>rd</sup> RACE Voided 2 claims - submitted by the same stable for a single horse.

Voided claim - no funds  
 The claim of #1 "You Vee Cee" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.  
 4<sup>th</sup> RACE #5 "Company You Keep" (Cristian Torres) unseated his rider in the post parade and ran loose briefly before being caught and returned on foot by the outrider. The horse ran and was eased and distanced.

A Stewards' inquiry was posted when #3 "Viva Voce" (Reylu Gutierrez) clipped heels and unseated his rider approaching the 3/4 pole. In addition, an objection was lodged by the rider of #3 alleging interference by the rider of #4 "Real Men Violin" (Corey Lanerie). After reviewing the race replay and interviewing the riders, the steward's determined that there was insufficient evidence to warrant a disqualification and the race was posted official.

5<sup>th</sup> RACE #7 "Bandon" (Martin Chuan) was a late scratch from the post parade on the advice of the KHRC veterinarian. The late scratch reduced the field to six and necessitated the cancellation of the Super Hi-5.  
 #4 "Captivated Dream" (Corey Lanerie), the winner, suffered a post-race heat stroke and was excused from the test barn after a blood sample was taken.

 7<sup>th</sup> RACE CLEAR

8<sup>th</sup> RACE #5 "Uncle Harry" (Gerardo Corrales) was pulled up near the 1/4 pole and required the assistance of the HRC veterinarians and the horse ambulance. It was reported that the horse had suffered an injury to his right foreleg and he was placed on the See State Vet list.

9<sup>th</sup> RACE #8 "Dragonera" (James Graham) was a late scratch from the post parade on the advice of the KHRC veterinarian.
