1st RACE #5 "Bobbie Sox" (Jose Riquelme) was a late scratch from the post parade on the advice of the KHRGC veterinarian. The scratch reduced the field to five, necessitating the cancellation of the Superfecta. The mutuels department made the proper refunds.
