INCIDENTS/INQUIRIES/OBJECTIONS


- **Race 5** → #5 Sir Lloyd had broken equipment (ripped a shoe) causing him to make a break before the start. A recall was unable to be called, and the race started. The Judges enacted the yellow warning lights as the Outrider made her way to the horse who was taken to the outside fence clear of all racing action. The race was contested without issue. The Board of Judges all agreed #5 Sir Lloyd be refunded to protect the betting public. After refunds were finalized the race was allowed to go official.
- **Race 10** → #2 Adventruferful Pete did swerve out causing wheels to hook with #7 Finish Strong prior to the $\frac{3}{4}$ mile marker. Both drivers got unhooked and continued racing and #7 ultimately beat #2 so no placing was needed.
- **Race 10** → #3 Bar Bee did go inside a pylon in the stretch while passing another horse acquiring an advantage. #3 was 6th placed 7th behind lapped on horses for the infraction.
