4th RACE An objection was lodged by the rider of fourth place #10 "Flashy Gem" (Fernando De La Cruz) alleging interference by the rider of the unofficial winner #2 "C C Cruise Control" (Corey Lanerie) near the 3/8 pole After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence to warrant a disqualification and the race was posted official.

#2 "Thirty Carats" (Geovanni Franco) was pulled up in the first turn and left the track on her own power. The KHRC veterinarians later examined the horse and placed her on the See State Vet list

#4 "Corvina" (Edgar Morales) was eased and required the assistance of the KHRC veterinarians and the horse ambulance. The horse was determined to be lame and was placed on the See State Vet list.

5th RACE An objection was lodged by the rider of eighth place #9 "Mr. Mariah" (Chel-c Bailey) alleging interference by the rider of fifth place #1 "Norgay" (Chris Landeros) leaving the 1/4 pole. As the objection did not involve the top four horses, the race was made official prior to the review. After reviewing the race replay and interviewing the riders, the stewards determined that there was insifficient evidence to warrant a disqualification and no change was made to the original order of finish.

8th RACE #4 "Quari Master" (Martin Garcia) finished seventh and required the assistance of the KHRC veterinarians and the horse ambulance. After diagnostics were perfored by the private veterinarian it was determined that the horse had suffered an injury to his right foreleg. The horse was transported to a Lexington clinic for further evaluation.
