TEST: 1<sup>st</sup> 1 & 6, 2<sup>nd</sup> 2 (C 4, 5 & 6), 3<sup>rd</sup> 1 & 3, 4<sup>th</sup> 1 & 5, 5<sup>th</sup> 3 (C 3 & 4-voided), 6<sup>th</sup> 2 & 3, 7<sup>th</sup> 2 & 5, 8<sup>th</sup> 3 & 10, 9<sup>th</sup> 7 & 10.

1<sup>st</sup> RACE CLEAR

2<sup>nd</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

Voided claim - horse name misspelled  
Voided claim - temporary owner's license

3<sup>rd</sup> RACE A Stewards' Inquiry was posted involving the start of #12 "Alder" (Gerardo Corrales). After reviewing the race replay and interviewing the starter and rider, the stewards determined that the horse made an attempt to break when the front doors opened timely, but appeared to be tangled in the gate and unable to break. During the attempt, the horse ultimately unseated the rider while still in the starting gate. The stewards declared #12 "Alder" a NON-STARTER and ordered the mutuels department to make the proper refunds.

4<sup>th</sup> RACE Superfecta, Trifecta and Show wagering were not offered when the field was reduced to four prior to the opening of wagering.

5<sup>th</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

Voided claim - insufficient funds

The claim of #4 "Hardly Mischievous" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

6<sup>th</sup> RACE #7 "Big Dreaming" was scratched by the trainer after the opening of wagering due to adverse track conditions. The scratch reduced the field to five, necessitating the cancellation of the Superfecta. The mutuels department made the proper refunds.

7<sup>th</sup> RACE CLEAR

8<sup>th</sup> RACE Race 4 was contested on the main track at the distance of one mile as specified in the conditions of the race. The change was posted and announced prior to the opening of wagering.
