1st RACE Voided claim - was submitted for scratched horse

The claim of #6 "Tim Tal" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

2nd RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.

3rd RACE CLEAR

4th RACE #3 "Murph Girl" (Martin Chuan) finished third and BLED. The filly was placed on the See State Vet list.


5th RACE CLEAR

6th RACE #5 "Timeless Bounty" arrived past the Lasix administration deadline and was permitted to race without the medication. The change was posted and announced prior to the opening of wagering.

9th RACE #3 "Cowboy Code" (Luan Machado) was on the inside and in tight quarters in the first turn, made contact with the rail several times and was pulled up near the 1/2 mile pole.
