RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

A Stewards' Inquiry was posted involving the start of #6 "Alpha Lea" (Brooke Bays) who finished sixth (last) after awkwardly leaving the gate well behind the field. After reviewing the race replay and interviewing the starter, the stewards determined that the horse, who did not have an assistant starter present at the request of the trainer, turned his head just prior to the break and slowly left the gate, almost unseating the rider who seemed unprepared for the start. Because the horse and rider appeared to cause their own trouble, there was no action taken and the race was posted official

2nd RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

The claim of #2 "Intrepid Heart" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
