1st RACE An objection was lodged by the rider of fourth place #2 "Determined Dancer" (Axel Concepcion) alleging interference by the rider of third place #6 "Eleonora" (Francisco Arrieta) near the 1/4 pole. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence of interference to warrant a disqualification and the race was posted official.

2nd RACE Voided claim - signer not Authorized Agent

3rd RACE Voided claim - incorrect date

4th RACE Voided claim - owner not licensed

The claims of both #1 "Time for Truth" and #5 "Skyro" were voided pursuant to HISA Rule #2262 when the horses were placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimants. The Horseman's Bookkeeper made the proper credits.

5th RACE An objection was lodged by the rider of eighth place #1 "Marigold Run" (Cristian A. Torres) alleging interference by the rider of the unofficial winner #2 "Up Before the Dawn" (Yedsit Hazlewood) near the 1/8 pole. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence of interference to warrant a disqualification and the race was posted official.

6th RACE CLEAR

7th RACE Super HI-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

Dead Heat for FOURTH

8th RACE CLEAR

9th RACE #4 "Stacking Tens" (Summer Pauly) was a late scratch from the post parade on the advice of the KHRG veterinarian. The scratch reduced the field to nine, necessitating the cancellation of the Jackpot 8. The mutuels department made the proper refunds.
