1st RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.

2nd RACE CLEAR

3rd RACE Superfecta and Trifecta wagering were not offered when the field was reduced to four prior to the opening of wagering.

4th RACE Race 4 was taken off the turf and was run at a distance of one mile on the main track as specified in the conditions of the race. The change was posted and announced prior to the opening of wagering.

Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.

5th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

6th RACE CLEAR

7th RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.

There was a 25 minute delay due to strong storms with lightning passing through the area. During the delay the horses remained in the paddock without incident. The turf was downgraded to "Yielding" and the main track was downgraded to "Sloppy" as a result.

#5 "Contemporary Art" (Florent Geroux) BLED, was eased, and was placed on the See State Vet list.

#3 "Fast as Flight" (Luis Saez), the winner, BLED while cooling out in the test barn and was placed on the See State Vet list.

8th RACE After the running of race 7, another storm with heavy rain and damaging winds passed through. The horses remained in their barns until it was safe for them to be brought to the paddock for saddling. This caused another 20 minute delay.
