1st RACE #15 "Beck's Dreamer" arrived past the Lasix administration deadline and was permitted to race without the medication. The change was posted and announced prior to the opening of wagering.

2nd RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

3rd RACE CLEAR

4th RACE Voided claim - insufficient funds

The claim of #10 "Golden Glider" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

5th RACE #4 "Gucci Gammy" (Mario Gutierrez) trailed the field, was distanced, and required the assistance of the KHRGC veterinarians and the horse ambulance. It was later reported that the filly had returned lame and she was placed on the See State Vet list.

6th RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.
