1st RACE #5 "Vivas in Front" (Rogelio Miranda) was injured in the starting gate and was a late scratch on the advice of the KHRC veterinarian.

6th RACE A Stewards Inquiry was posted involving several horses at the start. After reviewing the race replay and interviewing the riders of second place #7 "Sergeant Capps" (Rogelio Miranda) and ninth place (last) #6 "Spring Out Pass" (Christian Torres), the stewards determined that #7 broke in slightly and caused #6, who had left the gate slightly behind the others, to steady slightly. After the break, the rider of #6 did not pursue the others and trailed the field. There was no action taken and the race was posted official.

8th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

#2 "Altered Shot" (Luan Machado), who was fractious in the starting gate and unseated his rider, was backed out of the gate, examined by the KHRGC veterinarian and approved. Machado remounted the horse and the start was without incident.
