After reviewing the race replay and interviewing the riders of fourth place #5 "Tiz of Thee" (Rogelio Miranda), fifth place #8 "Royal Vicky" (Joseph Ramos), sixth place #4 "Deep State" (Gabriel Saez) and seventh place #6 "Three on the Tree" (Cristian Torres), the stewards determined that #8 angled out sharply nearing the 1/8 pole, causing #4, #5, and #6 to steady and lose momentum. For the interference #8 was disqualified from fifth and placed seventh, behind #6. Official order of finish: 3-1-2-5-4
