1st RACE CLEAR

2nd RACE Super Hi-5 wagering was mistakenly listed in the official program as a wagering option, but the race had only been carded with six horses. Therefore the wager was not offered and the correction was posted and announced prior to the opening of wagering.

Due to an additional scratch, Superfecta wagering was also not offered when the field was reduced to five prior to the opening of wagering.

3rd RACE The claim of #4 "Siesta Key" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

4th RACE CLEAR
5th RACE CLEAR

6th RACE Program correction - #12 "Pimlott" was mistakenly listed in the program to race without Lasix. The error was caught in a timely manner and the horse was permitted to race with the medication. The correction was posted and announced prior to the opening of wagering.

7th RACE CLEAR

8th RACE #4 "Super Happy" (Edgar Morales) was a late scratch from the post parade on the advice of the KHRG veterinarian.

An objection was lodged by the rider of second place #2 "Show Time" (Rafael Bejarano) alleging interference by the rider of the unofficial winner #8 "Gearing Up" (Brian Hernandez, Jr.) and #6 "Circle Tap" (Mario Gutierrez) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #2 angled out slightly while #6 on the outside came in slightly, both making incidental contact with #8 between them. When the order of the close finish was posted, the stewards did not entertain the objection involving #6 as he finished behind #2 and the objection involving #8 was disallowed. There was no change in the order of finish and the race was posted official.

9th RACE Jackpot 8 wagering was not offered when the field was reduced to nine prior to the opening of wagering.

#4 "Daring Madison" (Jaime A. Torres) was a late scratch from the post parade on the advice of the KHRG veterinarian. Two claims that had been submitted for the horse were voided.

#7 "Amber Vellella" (Edgar Morales) trailed the field, was eased, and required the assistance of the KHRG veterinarians and the horse ambulance. It was later reported that the filly had returned lame and she was placed on the See State Vet list.
