1st RACE Trifecta wagering was not offered when the field was reduced to four prior to the opening of wagering.

2nd RACE Due to a paperwork error after the draw of the race, #1 "Malibu Moonstruck" did not appear on program proofs used by the KHRC veterinarians to coordinate the treatment of horses with Lasix. As a result, the horse was not treated within the Lasix administration window. The horse was permitted to race without the medication and the change was posted and announced prior to the opening of wagering.

#4 "Wicked Street" (Miguel Mena) was a late scratch from the post parade on the advice of the KHRC veterinarian. The late scratch reduced the field to five necessitating the cancellation of the Superfecta. The mutuels department made the proper refunds.

The claim of #2 "Ready N Waiting" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
