TEST: 1st 7 (C 1, 2, & 6), 2nd 3 & 5, 3rd 2 (C 6), 4th 1 & 3, 5th 1 & 3, 6th 5 & 9 (C 8) 7th 1 & 7, 8th 3 & 7, 9th 2, 8 & 11.

1st RACE Super Hi-5 wagering was not offered when the field was reduced to five prior to the opening of wagering.

2nd RACE CLEAR

3rd RACE A Stewards Inquiry was posted involving the top two finishers in the stretch and, in addition, an objection was lodged by the rider of second place #2 "Inexorable" (Christopher Ernigh) alleging interference by the rider of the unofficial winner, #7 "Gucci Boy" (Francisco Arrieta) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #7 angled out and impeded #2, causing him to steady and lose momentum. For the interference, #7 was disqualified from first and placed second, behind #2. Official order of finish: 27614

4th RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

5th RACE CLEAR

6th RACE Voided claim- no owner listed

7th RACE Dead Heat for FOURTH

8th RACE #12 "Holy Moly Abraham" (Rogelio Miranda) appeared to suffer an injury approaching the three furlong pole and unseated his rider. The horse ran another 1/16 of a mile before being caught, and required the assistance of the KHRC veterinarians and the horse ambulance. After evaluation, it was determined that the horse had suffered a catastrophic injury to his right foreleg and he was humanely euthanized.

A Stewards Inquiry was posted involving second place #4 "Straight and Level" (Brian Hernandez, Jr.) who drifted out in the stretch and appeared to carry third place #5 "Rivalry" (Cristian Torres) out slightly. After reviewing the race replay and interviewing the riders, the stewards determined that the incident did not have any impact on the order of finish and the race was posted official.

9th RACE #10 "Tapage" (Martin Chuan) was fractiou and unseated his rider in the starting gate but remained in place. The rider remounted the horse in the gate and the start was without incident.
