TEST: 1<sup>st</sup> 3 & 6, 2<sup>nd</sup> 5 (C 2, 3-voided & 6-voided), 3<sup>rd</sup> 1 & 4, 4<sup>th</sup> 5 & 6 (C 1), 5<sup>th</sup> 1 & 6, 6<sup>th</sup> 5 & 10, 7<sup>th</sup> 2 & 4, 8<sup>th</sup> 3 & 6, 9<sup>th</sup> 8 (C 4).

1<sup>st</sup> RACE CLEAR

2<sup>nd</sup> RACE The claims of both #3 "Punctuality" and #6 "Attest" were voided pursuant to HISA Rule #2262 when the horses were placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant.s The Horseman's Bookkeeper made the proper credits.

3<sup>rd</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

4<sup>th</sup> RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.

Voided claim - submitted for scratched horse

5<sup>th</sup> RACE CLEAR

6<sup>th</sup> RACE #5 "Condon Candy" (Declan Cannon), the winner, required the assistane of the KHRC veterinarians and the horse ambulance. A blood sample was taken and the horse was excused from the test barn.

7<sup>th</sup> RACE #3 "Church Service" (Gabriel Saez) was a late scratch from the post parade on the advice of the KHRC veterinarian.

#7 "Boitoro" (Cristian Torres) unseated his rider in the post parade and ran loose briefly before being caught by the outrider. The horse was approved by the KHRC veterliarian, remounted, and raced without incident.

8<sup>th</sup> RACE #6 "Eli's Promise" (Mitchell Murrill), the winner, was mistakenly listed in the past performances as having worn blinkers in his previous start at Hawthorne Race Course on June 25, 2023. That error and the fact that the horse would not wear blinkers in this race were announced prior to the start.
