1st RACE When one of 2 claims that were submitted for #1 "Refined Design" was voided because there were no funds in owner David Nunez's account, the horse was awarded to the remaining claimant, Bruno Schickendanz. Shortly after the race, it was discovered that a wire transfer from Nunez had been received by Ellis Park prior to the start of racing, but had not yet been posted to his account. The stewards ordered that a 2 way shake be conducted, and the horse was ultimately awarded to Schickendanz, the winner of the 2 way shake.

2nd RACE CLEAR

3rd RACE #7 "Silvertown" (Summer Pauly), the winner, required the assistance of the KHRG veterinarians and the horse ambulance. A claim submitted for the filly was voided pursuant to HISA Rule #2262 when she was placed on the KHRG Veterinarian's list. The Horseman's Bookkeeper made the proper credits.

5th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

6th RACE CLEAR

7th RACE #7 "Champagne Candice" (Luan Machado) was a late scratch from the post parade on the advice of the KHRG veterinarian.
