1st RACE #3 "Smoothdini" (Rafael Bejarano) finished ninth (last) and suffered a post-race heatstroke. The horse, who required treatment from the KHRC veterinarians, was placed on the See State Vet list.

4th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.


5th RACE Due to the race being off the turf, several scratches were received after the opening of wagering that reduced the field to five, necessitating the cancellation of both Super Hi-5 and Superfecta wagering. The mutuels department made the proper refunds.


6th RACE CLEAR


7th RACE Voided claim - insufficient funds

8th RACE #6 "Sgt. Pepper" (James Graham) popped the front doors of the starting gate open prior to the break, but the rider stayed aboard and the assistant starter held the horse in place. The doors were closed and the start was without incident.

9th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.
