#1 "Hard to Get" was injured in the paddock and was a late scratch on the advice of the KHRGC veterinarian. A claim that had been submitted for the horse was voided.

CLEAR 6th RACE

A Stewards Inquiry was posted involving an 7th RACE incident in the stretch and, in addition, an objection was lodged by the rider of sixth place #4 "Sense of Freedon" (Joseph C. Bealmear) alleging interference by the rider of third place #5 "Mr. Vaggio" (Edgar Morales) near the 1/8 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #5 angled in and caused #4 to check sharply, clip heels and lose momentum. For the interference #5 was disqualified and placed sixth, behind #4.
