1st RACE CLEAR

2nd RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.

The claim of #4 "Vagabond Shoes" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3rd RACE The claim of #8 "Rational Theory" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

4th RACE CLEAR

5th RACE Voided claim - horse name misspelled and insufficient funds
#1 "Hard to Get" was injured in the paddock and was a late scratch on the advice of the KHRGC veterinarian. A claim that had been submitted for the horse was voided.

6th RACE CLEAR

7th RACE A Stewards Inquiry was posted involving an incident in the stretch and, in addition, an objection was lodged by the rider of sixth place #4 "Sense of Freedom" (Joseph C. Bealmear) alleging interference by the rider of third place #5 "Mr. Vaggio" (Edgar Morales) near the 1/8 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #5 angled in and caused #4 to check sharply, clip heels and lose momentum. For the interference #5 was disqualified and placed sixth, behind #4.

8th RACE CLEAR

9th RACE #5 "Brushfire" (Rafael Bejarano) was a late scratch from the post parade on the advice of the KHRGC veterinarian.
