1st RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

2nd RACE #2 "Drewvictory" (Martin Garcia) was a late scratch from the post parade on the advice of the KHRG veterinarian. The scratch reduced the field to five, necessitating the cancellation of the Superfecta. The mutuels department made the proper refunds.

3rd RACE Voided claim - owner name misspelled

The claim of #8 "Lucius Verus" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

4th RACE CLEAR

6th RACE #1 "Jerseys Parade" (Adam Beschizza) was eased, pulled up soon after the finish, and required the assistance of the KHRG veterinarians and the horse ambulance. It was later reported that the horse had returned unsound and she was placed on the See State Vet list.

8th RACE CLEAR

9th RACE Jackpot 8 wagering was not offered when the field was reduced to nine prior to the opening of wagering.

An objection was lodged by the rider of second place #11 "Call the Bullpen" (Jaime Torres) alleging interference by the rider of the unofficial winner, #9 "Embrace Time" (Florent Geroux) in deep stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there was insufficient evidence of interference to warrant a disqualification. There was no change in the order of finish and the race was posted official.
