1st RACE Voided claim - incorrect date

2nd RACE Voided claim - no race number on envelope

The claim of #4 "Bearister" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3rd RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.

#1 "Tuskegee Airmen" (Gabriel Saez) was a late scratch from the post parade on the advice of the KHRG veterinarian. The scratch reduced the field to four, necessitating the cancellaiton of the Trifecta. Management also opted to cancel Show wagering, The mutuels department made the proper refunds.

4th RACE CLEAR

5th RACE Program correction - #5 "Smokin Hot Blonde" was mistakenly listed in the program to race with Lasix. The error was caught in a timely manner and the horse was permitted to race without the medication. The correction was posted and announced prior to the opening of wagering.

#1 "Ocean Ripple" (Rafael Bejarano) finished ninth (last) and suffered a post-race heatstroke. The filly required treatment from the KHRG veterinarians and she was placed on the See State Vet list.

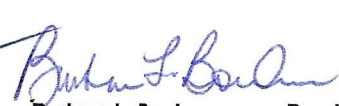
6th RACE #9 "Dancewhenyoucan" (Ben Curtis) unseated her rider shortly after leaving paddock and ran loose, evading the outriders until being caught past the 1/2 mile pole. The filly was scratched by the stewards.

7th RACE CLEAR

8th RACE An objection was lodged by the rider of second place #5 "Volendam" (Yedsit Hazlewood) alleging interference by the rider of the unofficial winner, #6 "Corona de Ore" (Brian J. Hernandez, Jr.) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there had been no interference. There was no change in the order of finish and the race was posted official.

9th RACE The race was taken off the turf and contested at one mile on the sloppy main track due to a heavy rainstorm that had passed through the area. The change of surface was posted and announced prior to the running of race 8.
