2nd RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

#4 "King Bukele" was injured prior to entering the paddock and was a late scratch on the advice of the KHRC veterinarian. The late scratch reduced the field to four, necessitating the cancellation of the Trifecta. The mutuels department made the proper refunds.

A Stewards' Inquiry was posted involving the stretch run. After reviewing the race replay and interviewing the riders of second place #1 "Moon Cat" (Jose E. Lopez), fifth place #4 "Mahoney Road" (Corey Lanerie) and seventh place #8 "Uncle Berley" (Christopher Emigh) the stewards determined that #1 veered out into #4 who was forced out into the path of #8, causing both of those horses to steady. For the interference, #1 was disqualified from second and placed seventh, behind
