1st RACE Program Error - Although the race was carded with 5 betting interests, Superfecta wagering was mistakenly listed as a betting option. No Superfecta wagers were accepted.

The claim of #2 "East of India" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits

2nd RACE #3 "Hush Hush" was injured in the paddock and was a late scratch on the advice of the KHRC veterinarian.

#7 "Sis Boom Bob" (Mitchell Murrill) bolted, was eased, and was placed on the Stewards' List.

3rd RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

4th RACE CLEAR

5th RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

#4 "Blazing Summer" (Reylu Gutierrez) ran fourth and required the assistance of the KHRC veterinarians and the horse ambulance. The horse, who had been chosen as the post race special, had a blood sample drawn and was excused from the test barn.

6th #9 "Becky Thatcher" (Gage Holmes) unseated her rider and ran loose behind the starting gate. The horse was captured by the outrider, remounted, and the start was without incident.

7th RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.
