3rd RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

Voided claim - no funds

An objection lodged by the rider of #2 "Vaporizer" (Francisco Arrieta) alleging interference by the rider of #8 "Horse of the Sea" (Jaime Torres) in deep stretch was not posted or announced when #2 was determined to be the winner of a close photo finish.

The claim of #6 "Mouqeer" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

4th RACE #3 "Maroon Tide" (Danny Sheehy) flipped and fell over behind the starting gate and was a late scratch on the advice of the KHRG veterinarian. Both horse and rider escaped serious injury.

5th RACE A Stewards Inquiry was posted involving an incident leaving the 1/4 pole and, in addition, an objection was lodged by the rider of seventh place (last) #9 "Swerve" (Brian Hernandez, Jr.) alleging interference by the rider of second place #2 "Clark's Corner" (Francisco Arrieta) also leaving the 1/4 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #2 came off the rail to circle several rivals, opened the gap for #9 to come up the rail then quickly dropped back down, causing #9 to steady sharply and lose his action. For the interference #2 was disqualified from second and placed seventh (last), behind #9.
