1st RACE This race which had been scheduled for 1-1/16 miles on the turf, was contested at One Mile on the main track as listed in the conditions of the race.

2nd RACE Voided claim - owner name misspelled

A Stewards Inquiry was posted when #8 "Wings of Gabe" (Carlos Diaz) did not break from the starting gate. After reviewing the race replay and interviewing the starter, it was confirmed that the horse had been afforded a fair start, and that the horse had REFUSED. There was no action taken and the race was posted official.

3rd RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

Voided claim - no funds

4th RACE CLEAR

5th RACE After a heavy rain, the already saturated main track had standing water in several spots. The track maintenance crew worked the track for 30 minutes in an attempt to remove the water. Horses remained in the paddock and were sent out when improvement had been made by the crew. Ultimately, races 5-9 were cancelled in the interest of safety to all participants. The mutuel department made the proper refunds.
