1st RACE Voided claim - insufficient funds

2nd RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

3rd RACE #10 "White Dove" (Gerardo Corrales) was pulled up soon after the start and required the assistance of the KHRC veterinarians and the horse ambulance. The horse suffered an injury to his right foreleg and was placed on the See State Vet list.

4th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

Voided 2 claims - submitted for scratched horse

#4 "Sonador" (Javier Padron-Barcenas) was injured in the paddock and was a late scratch on the advice of the KHRC veterinarian. The scratch reduced the field to five, necessitating the cancellation of the Superfecta. The mutuels department made the proper refunds.

5th RACE #4 "Pinotslilgiri" (Jack Gilligan) was injured behind the starting gate and was a late scratch on the advice of the KHRC veterinarian.

An objection was lodged by the rider of seventh place #1 "Sotona" (Cristian Torres) alleging interference by the rider of the unofficial winner #10 "Song of Norway" (Walter Rodriguez) at the start. After reviewing the race replay and interviewing the riders there was insufficient evidence to warrant a disqualification and the race was posted official.

6th RACE #7 "Areuhavingfunyet" (Francisco Arrieta) was a late scratch from the post parade on the advice of the KHRC veterinarian.

7th RACE CLEAR

8th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

9th RACE #1 "Testimony Time" (Luan Machado) finished second and required the assistance of the KHRC veterinarians and the horse ambulance. It was reported that the horse had suffered an injury to his left foreleg. #10 "Category Ten" (Martin Chuan) was eased and also required the assistance of the KHRC veterinarians and the horse ambulance. It was reported that the horse had returned lame. Both horses were released to the care of their private veterinarians and both were placed on the See State Vet list.
