1st RACE # "Beck's Spirit" (Corey Lanerie) was distanced
and left the track on his own power.

2nd RACE Voided claim - no funds

3rd RACE #6 "Fasta Lavista Baby" (Mario Gutierrez) was
pulled near the 5/16 pole and required the assistance of the KHRG
veterinarians and the horse ambulance. It was later reported that the horse,
who had stumbled several times before being pulled up, was placed on the
See State Vet list.

4th RACE Voided claim - horse name misspelled
Voided claim - no race number on envelope

The original claimant, in a 10 way shake, of #6
"Shortstop" (owner-Yelmy Rosales, trainer - Paulo Campos) was found to
be in possible violation of the regulation that governs claiming by a
transfer of funds to her account by Nery Alvarez, who had also submitted a
claim for the horse. The stewards voided the claims submitted by Alvarez
and Rosales prior to the horse being released from the test barn. After
those 2 claims were voided by the stewards, 8 valid claims remained for the
horse. David K. Cook was the eventual winner of the second shake and the
horse was released to him.

The claim of #4 "Purse Thief" was voided
pursuant to HISA Rule #2262 when the horse was placed on the KHRGC
Veterinarian's list while in the test barn and prior to transfer to the claimant.
The Horseman's Bookkeeper made the proper credits.

7th RACE Super Hi-5 wagering was not offered when the
field was reduced to six prior to the opening of wagering.

8th RACE Dead Heat for FIFTH (Super Hi-5 race)

9th RACE #11 Twirling Troillet" (Edgar Morales) finished
third and suffered a post-race heatstroke. The horse, who required
treatment from the private veterinarian, was placed on the See Vet list.
