The original claimant, in a 10 way shake, of #6 "Shortstop" (owner-Yeimy Rosales, trainer - Paulo Campos) was found to be in possible violation of the regulation that governs claiming by a transfer of funds to her account by Nery Alvarez, who had also submitted a claim for the horse. The stewards voided the claims submitted by Alvarez and Rosales prior to the horse being released from the test barn. After those 2 claims were voided by the stewards, 8 valid claims remained for the horse. David K. Cook was the eventual winner of the second shake and the horse was released to him.

The claim of #4 "Purse Thief" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
