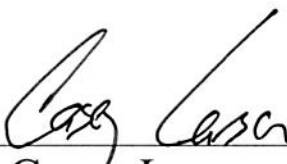

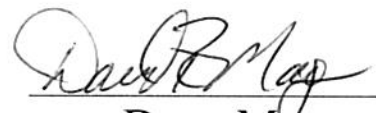
- Race 11 - #4 Seaside Charm was scratched Lamé on the advice of the State Vet after warmup – 14 days – Must Qualify.
- Race 11 - #5 Miss Jum Jabber was pulled up out of precaution by the driver post-race and the equine ambulance was called to van the horse back to the barns on the recommendation of the State Vet. Miss Jum Jabber was placed on the States Vets List.
- Race 14 – After two horses violated the breaking rule in the stretch for an extended break the Board of Judges had a double disqualification. #6 King Of The Wind was 5th placed 7th for an extended break of over 1/8 of a mile and #2 Gabes Luck was 6th placed 5th placed 6th due to an extended break of under 1/8 a mile but exceeding 25 strides. #3 Nicholson was 7th placed 6th placed 5th and the race was allowed to go official.
