#4 "Foreseen" (Edgar Morales) stumbled at the start, trailed the field, was pulled up near the 1/8 pole and left the track on her own power. It was later determined that the horse had returned lame and she was placed on the See State Vet list.

RACE #7 "Birthday Girl" (Jaime A. Torres) broke slowly, trailed the field, and was pulled up approaching the 1/4 pole. The filly required the assistance of the KHRGC veterinarians and the horse ambulance. It was determined that the horse had returned lame and she was placed on the See State Vet list.

RACE CLEAR

9th RACE A Stewards Inquiry was posted involving several horses in deep stretch and, in addition, an objection was lodged by the rider of sixth place #9 "Moving to Kentucky" (Alex Achard) alleging interference by the riders of both third place #7 "Publius" (Carlos Eduardo Lopez) and fourth place #5 "Victory Dash" (Edgar Morales) inside the 1/16 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #5 ducked out sharply and impeded both #7 and #9. Because the interference was caused solely by #5, the objection lodged by #9 against #7 was disallowed. The inteference by #5 was confirmed and he was disqualified from fourth and placed sixth, behind #9. Official order of finish: 11-10-7-3-9
