1<sup>st</sup> RACE CLEAR

2<sup>nd</sup> RACE Four claims were submitted for #4 "Bushido". The stewards were informed that one of the claimants had insufficient funds in their account and that claim was voided. After the horse went to owner Ron Hendrickson in the three way shake, it was discovered that the owners whose claim had been voided had communicated a transfer request to the horseman's bookkeeper that had not yet been executed. The stewards then ordered a new four way shake that included that claim submitted by Peter Proscia and David Staudacher that had been previously voided. The eventual winner of the reshake was owner David Jacobson. During the entire process the horse remained in the test barn and was not released until the owner was finally decided by the outcome of the 4 way shake.

3<sup>rd</sup> RACE Dead Heat for FIFTH (Super Hi-5 race)

4<sup>th</sup> RACE Super Hi-5 wagering was mistakenly listed in the official program as a option, but wagers were not accepted as the race was carded with six horses.

5<sup>th</sup> RACE Program correction - #6 "Justifiable Star" was mistakenly listed in the program to race with Lasix. The error was caught in a timely manner and the horse was permitted to race without the medication. The correction was posted and announced prior to the opening of wagering.

6<sup>th</sup> RACE Super Hi-5 wagering was mistakenly listed in the official program as a option, but wagers were not accepted as the race was carded with six horses. In additon, Superfecta wagering was not offered when the field was reduced to five horses prior to the opening of wagering.

7<sup>th</sup> RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.

8<sup>th</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

9<sup>th</sup> RACE CLEAR

10<sup>th</sup> RACE #2 "Sturgeon Moon", the winner, was ridden by Tyler Gaffalione. Jockey Axel Concepcion, who had been originally named to ride and replaced by the owner, was also paid an amount equal to Gaffalione.
