1st RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

#1 "Barrett" (Gerardo Corrales) was a late scratch from the post parade on the advice of the KHRC veterinarian. The scratch reduced the field to four, necessitating the cancellation of the Trifecta. The mutuels department made the proper refunds.

2nd RACE Dead Heat for SHOW

3rd RACE Voided claim - insufficient funds

4th RACE #3 "Lisa's Guy" (Ferrin Peterson) was a late scratch from the post parade on the advice of the KHRC veterinarian.

7th RACE An objection was lodged by the rider of fifth place #4 "Of the Moment" (Jose E. Lopez) alleging interference by the rider of fourth place #1 "Twirling Roses" (Mitchell Murrill) in the stretch. After reviewing the race replay and interviewing all riders involved, the stewards determined that #4, who was on the inside and in tight quarters, was forced to check when #1a "Kennesaw" (Colby J. Hernandez) angled in slightly, causing several horses to his inside to steady. As #4 finished in front of #1a, there was no change in the order of finish and the race was posted official.

8th RACE An objection was lodged by the rider of fourth place #9 "Levity" (Rafael Bejarano) alleging interference by the rider of the unofficial winner #10 "Encourage" (Brian J. Hernandez, Jr.). After reviewing the race replay and interviewing the riders, the stewards determined that there had been no interference and the race was posted official.
