1st RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

2nd RACE CLEAR

3rd RACE The claim of #3 "He's Pretty Lucky" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

4th RACE CLEAR

5th RACE #4 "First to the Party" (Julien Leparoux) was a late scratch from the post parade on the advice of the KHRC veterinarian.

6th RACE CLEAR

7th RACE The claim of #7 "Russian Mafia" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

8th RACE An objection was lodged by the rider of second place #1 "Zoffa" (James Graham) alleging interference by the riders of the unofficial winner #7 "Union Soldier" (Mitchell Murrill) and #4 "Awesummer" (Adam Beschizza) who finished third. The objection was lodged prior to the order of finish being posted. After reviewing the race replay and interviewing the riders, the objection against #4 was not entertained as #1 finished in front of him. There was insufficient evidence of interference to support the objection against #7 which was disallowed. There was no change in the order of finish and the race was posted official.
