2nd RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

3rd RACE #4 "Brooklyn Drew" (Gabe Saez) popped the front doors of the gate open, but was held in place by the assistant starter and the rider stayed aboard. The horse was backed out, examined and approved by the KHRG veterinarian, and the start was without incident.

4th RACE CLEAR

5th RACE #3 "I'm a Cookie Lover" (Corey J. Lanerie) was a late scratch from the post parade on the advice of the KHRG veterinarian.

6th RACE #10 "Farm Team" (Samuel Camacho, Jr.) was a late scratch from the post parade on the advice of the KHRG veterinarian.
