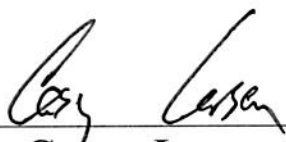

INCIDENTS / INQUIRIES / OBJECTIONS / JUDGES LIST

- Race 2 - #6 Merry Zee was 1st placed 10th due to switching to the pace in the stretch, violating the Extended Break Rule.
- After conclusion of the 16-race card, 6 non-wagering races were held to make up from 8-16-2026 cancellation.
- Non-Bettor Race 4 – After the start #5 Fendilicious had a broken left line. The Judges activated the yellow warning lights and instructed the outrider to find position on the backstretch as the horse was moved to the outside. The field of horses continued to race with the yellow warning lights activated and the driver of #5 was unseated past the half and the horse was caught prior to the turn by the outrider. At no time did any other driver pull up with concern. The driver was checked by medical team and was not transported and did request to be removed from his final mounts.
