A citywide power outage occurred after the running of race 2, and before the race could be posted official. There was no working video or public address system during the outage that originated off the grounds and included a large area. The delay ultimately lasted one hour. Power was restored and the payoffs were finally posted for race 2. During the delay, the unsaddled horses calmly remained in the paddock without incident.

- RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.
- RACE #2 "Tapitoro" (Cristian Torres) was pulled up abruptly nearing the 1/2 mile pole and required the assistance of the KHRGC veterinarians and the horse ambulance. The filly was transported off the track and diagnostics were performed. It was determined that she had suffered a catastrophic injury to her left foreleg and she was humanely euthanized.
- Super Hi-5 wagering was not offered when the RACE field was reduced to six prior to the opening of wagering.
