A Stewards Inquiry was posted when #6 "Spirit of Royal" (Florent Geroux) unseated his rider shortly after the start. After reviewing the race replay, the stewards determined that the horse had stumbled and unseated the rider, and no other rival was involved. No action was taken and the race was posted official. The horse ran with the field and was caught without incident. The rider escaped injury.

8th RACE CLEAR

9th RACE #13 "Rockin His Sox Off" got loose on the way to the paddock and ran along the levee and surrounding area before being apprehended by a group that included several KHRG veterinarians. The colt was a late scratch by the stewards.
