The claim of #6 "Enjoy it Strait" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

2<sup>nd</sup> RACE CLEAR

3<sup>rd</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

#3 "Dark Dahlia" (Julien Leparoux) popped the front doors of the gate open, but was held in place by the assistant starter and the rider stayed aboard. The horse was backed out, examined and approved by the KHRG veterinarian, and the start was without incident.

5<sup>th</sup> RACE The claim of #8 "Cat Fast" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

6<sup>th</sup> RACE CLEAR

7<sup>th</sup> RACE

A Stewards Inquiry was posted when #6 "Spirit of Royal" (Florent Geroux) unseated his rider shortly after the start. After reviewing the race replay, the stewards determined that the horse had stumbled and unseated the rider, and no other rival was involved. No action was taken and the race was posted official. The horse ran with the field and was caught without incident. The rider escaped injury.


8<sup>th</sup> RACE CLEAR

9<sup>th</sup> RACE #13 "Rockin His Sox Off" got loose on the way to the paddock and ran along the levee and surrounding area before being apprehended by a group that included several KHRG veterinarians. The colt was a late scratch by the stewards.
