2nd RACE #2 "Bad Beat Brian" (Erik Asmussen) was a late scratch from the post parade on the advice of the KHRG veterinarian.

5th RACE #12 "Jackie and Ginger" (Gabriel Saez) was a late scratch from the post parade on the advice of the KHRG veterinarian.

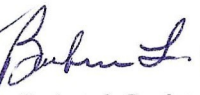
6th RACE CLEAR

7th RACE A Stewards Inquiry was posted when #1 "Nyquist Frequency" (Yedsit Hazlewood) bobbled, unseated his rider and bolted to the outside approaching the 1/16 pole. The horse, who appeared to be injured, continued to run, was caught by the outriders past the finish, and required the assistance of the KHRG veterinarians and the horse ambulance. After reviewing the race replay there was no action taken and the race was posted official. The rider escaped serious injury. After diagnostics, it was determined that the gelding had suffered a catastrophic injury to his right foreleg and he was humanely euthanized.

8th RACE #3 "French Mistress" (James Graham) was eased, pulled up near the 1/8 pole, and left the course on her own power. The KHRG veterinarians later reported that the filly had returned lame and she was placed on the See State Vet list.
