The claim of #3 "McKinsense" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3<sup>rd</sup> RACE A Stewards Inquiry was posted involving the top two finishers approaching the wire and, in addition, an objection was lodged by the rider of second place #2 "Positive Equity" (Axel Concepcion) alleging interference by the rider of the unofficial winner #8 "T V Channel" (Yedsit Hazlewood) near the finish. After reviewing the race replay and interviewing the riders, the stewards determined that #8 maintained a straight course on the inside and that #2 took a slight step in and initiated contact with the #8, causing Concepcion on #2 to lose control of his horse as he appeared to lose his balance. There was no change in the order of finish and the race was posted official.

Program correction - #1 "Blakely's Boy" was mistakenly listed in the program to race with Lasix. The error was caught in a timely manner and the horse was permitted to race without the medication. The correction was posted and announced prior to the opening of wagering.

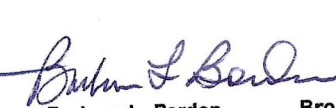
6<sup>th</sup> RACE A Stewards Inquiry was posted involving the top two finishers near the 1/8 pole and, in addition, an objection was lodged by the rider of second place #7 "Livehappy" (Gerardo Corrales) alleging interference by the rider of the unofficial winner #2 "Twilight Delight" (Yedsit Hazlewood) near the 1/8 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #2 angled in slightly while passing #7 to his inside. There was no change in the order of finish and the race was posted official.

7<sup>th</sup> RACE A Stewards Inquiry was posted involving the top three finishers in the stretch and, in addition, an objection was lodged by the rider of third place #1 "Ali's Glory" (Rafael Bejarano) alleging interference by the rider of the unofficial winner #9 "Henriques" (Francisco Arrieta) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #1 steadied slightly while being passed on the outside by #9, while second place #8 "Social Deception" (Erik Asmussen) maintained a straight course. There was no change in the order of finish and the race was posted official.

8<sup>th</sup> RACE #2 "She's On a Roll" (Cristian A. Torres) was fractious in the starting gate and was backed out, examined and approved by the KHRG veterinarian. The filly was reloaded and the start was without incident.
