TEST: 1<sup>st</sup> 3 & 8, 2<sup>nd</sup> 3 & 8, 3<sup>rd</sup> 3 & 6-clm voided (C 4), 4<sup>th</sup> 3 & 6, 5<sup>th</sup> 4 & 5, 6<sup>th</sup> 4 & 12, 7<sup>th</sup> 3 & 8, 8<sup>th</sup> 1 & 8, 9<sup>th</sup> 4 & 10.

1<sup>st</sup> RACE #1 "Equal Success" was a late scratch when she unseated her rider in the post parade, ran loose, and fell while jumping the outside rail. The filly was later examined by the KHRGC veterinarians and was placed on the See State Vet list.

#7 "Honeybeebobbie" (Erick Fuentes) bore out in the turn and was eased.

2<sup>nd</sup> RACE CLEAR

3<sup>rd</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

Voided claim - no date listed

The claim of #6 "Good Like Magic" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

#5 "True Jedi" (Jaime Torres) trailed the field and was eased. It was later reported by the KHRGC veterinarians that the horse had suffered a post-race heatstroke and he was placed on the See State Vet list.

An objection was lodged by the rider of third place #2 "Everland" (Luan Machado) alleging interference by the rider of the unofficial winner, #4 "Flashy Lass" (Erik Asmussen) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #4 angled out in the stretch and made contact with #2 several times while approaching the close finish. For the interference, #4 was disqualified and placed third behind #2. Official order of finish: 5-2-4-8-1




